Chairman Aderholt and Ranking Member DeLauro,

We are writing to request that you prioritize the Low Income Home Energy Assistance Program (LIHEAP) in your Fiscal Year (FY) 2024 appropriations bill by including the highest level of funding possible for this program that provides critical support to our most vulnerable citizens.

LIHEAP helps some of the neediest families in the country with their energy bills by providing them with vital assistance during both the cold winter and hot summer months. According to the 2018 National Energy Assistance Survey, 92 percent of LIHEAP recipients have at least one household member who is a child, elderly, or disabled. For these households, LIHEAP funding has been a lifeline during challenging economic times. Access to affordable home energy is not a luxury – it is essential for the health and safety of families.

Supplemental funding for utility assistance provided by recent emergency stimulus bills has helped address arrearages for families struggling due to pandemic-related unemployment. However, these temporary supplemental funds will not address the ongoing energy needs of millions of eligible households still struggling with the rising cost of monthly expenses. Living at the lowest levels of poverty, recipients of these funds are forced to make choices every day between food, medicine, or utilities. Robust funding for LIHEAP in FY 2024 will ensure these income-constrained households do not once again fall through the cracks.

We understand the discretionary budget challenges the Committee will be facing in FY 2024. However, LIHEAP is chronically underfunded. In recent years, the program has only had funds to serve one out of six eligible households. Even with supplemental emergency funds, the program will not be able to reach all households in need. As prices have risen for everything from a gallon of milk to a gallon of gasoline, many income-constrained families and seniors will have fewer resources available to meet their basic needs.

As you finalize your FY 2024 Labor, Health and Human Services, Education and Related Agencies Appropriations bill, we ask that you take into account the tremendous and growing need for LIHEAP. We urge you to prioritize this program and maximize funding.
